

**Traxx Siberians' Sale Contract and Guarantee**

Tami R. Jones, hereafter referred as seller, and

1. The above named dog is a pure bred Siberian Husky registerable with the American Kennel Club (AKC).
  - a. The price of \$ \_\_\_\_\_ to be paid immediately upon the purchase of the above named Siberian Husky, hereafter referred to as dog. Should payments be made the agreement shall be written on the back of this page and initialed by buyer and seller. Seller may, at her discretion, keep possession of AKC registration slip of the above named dog until full purchase price has been paid (in the case of payments), or in the case of payment by check, until the check has cleared the bank.
2. Buyer agrees to have dog cleared by their own licensed veterinarian within 3 working days of purchase to ensure that dog is normal and healthy. Sellers responsibility for communicable disease is void if not reported within 10 days of purchase. Upon oral conformation of any genetic problem from examining vet, dog may be returned to breeder/seller within 5 working days of notification, for dog of equal value or full refund of purchase price. Replacement/refund is contingent on dog being returned to seller in the same condition that it left seller's property, and with a written explanation by the buyer's licensed veterinarian of choice. Expense of returning dog to breeder/seller is the sole responsibility of the buyer.
3. Buyer agrees to provide routine care of dog, which must include a licensed veterinarian recommended immunization and health care program, with preventative heart worm medication included. Dog should be kept parasite free as possible. Buyer must, also, provide a proper environment that is: food of sufficient quality and quantity to keep dog in optimum condition, clean water, adequate shade and shelter to protect from elements, with a fenced in yard and adequate exercise. Under NO circumstances may dog be allowed to run unsupervised in a non-fenced area.
4. Dog will be replaced should it develop juvenile cataracts or hip dysphasia, provided breeder/seller is given a signed documentation of defect by a Veterinary Opthamologist or Radiologist, and proof of spaying/neutering, or euthanasia. If not euthanised, the dog will become the property of the seller. Seller reserves the right to require a second opinion from another veterinarian of her choice, at her expense. A malnourished, obese, or abused condition will void replacement of dog. Seller is not responsible for reimbursement of accumulated expenses, only for the Replacement of dog. Replacement will be from the Seller's next planned litter of a

*puppy of equal value. A litter will NOT be bred solely for the replacement of dog.*

5. *Buyer must keep the AKC registered name on litter registration slip filled in by the seller, or any guarantee will be null and void.*
6. *Dog is being sold as PET QUALITY, with limited AKC registration. Buyer understands that this means no offspring from this dog is entitled to AKC registration nor will dog be eligible for AKC conformation competition. Under NO circumstances may this dog be used for breeding.*
  - a. *Should the buyer later wish to compete in show or breed, seller will re-evaluate dog at 2 (two) years of age, and if the dog is of competitive quality, and if the buyer provides proof of CERF certification eligibility at 6 (six) months, 1 (one) year, 18 (eighteen) months, and 2 (two) years of age, and OFA certification of GOOD, or better, seller will, at her discretion, change the registration of dog to full, provided a new contract is signed. Any AKC fees related to this change is the sole responsibility of the buyer.*
  - b. *Seller/Breeder encourages buyer to spay or neuter this dog, provided the buyer has no future interest in showing/breeding.*
7. *If the original buyer cannot keep dog, for any reason,, buyer must notify seller in writing, via U.S. Postal Service, certified mail, of their intentions. Breeder/seller will choose to either house the dog, until a home is found, or assist buyer in interviewing/screening new owners for dog. Under NO circumstances shall dog be surrendered to an Animal Shelter, sold/ given to a pet store, or pet dealer for re-sale, or sold to any animal testing/research facility.*
8. *Buyer and seller have read, and fully understand, and are in agreement with all the terms and conditions of this 2 page contract. Any other agreements or amendments to this contract will be written on the front or back of these pages, and initialed by both parties. Failure to comply with any of these clauses entitles seller to repossession of the dog with it's AKC Registration Certificate, signed by buyer, and further, punitive damages for up to \$2500.00 and all legal fees incurred. Court proceedings shall take place in the county of the seller, and possession of dog must be returned to the seller until dispute is settled. This is solely for the protection of the dog, and shall be enforced, particularly in the case of abuse or neglect of the dog.*
